Mr Thomas' sale has been undertaken to accommodate buying interest from a new blue-chip institutional investor.

Charles Peal (Non-executive director) purchased 55,473 Shares at a price of 466.395p. Following this purchase Mr Peal is beneficially interested in 565,366 Shares representing 1.9 per cent of the Company's issued share capital.
